

Borgestad ASA: Korreksjon tilknyttet mulig reparasjonsemisjon

Skien, 1. mars 2022: Det vises til børsmelding fra Borgestad ASA ("Selskapet") 28. februar 2022 vedørende planlagt rettet emisjon av nye aksjer ("Emisjonen") og delvis innløsning av obligasjon.

Som nevnt i børsmeldingen vil styret, med forbehold om en vellykket gjennomføring av Emisjonen, foreslå for Selskapets ekstraordinære generalforsamling at det gjennomføres en etterfølgende reparasjonsemisjon av nye aksjer i Selskapet. Siden tegningsperioden i den Rettede Emisjonen først vil lukkes i dag, 1. mars 2022, vil reparasjonsemisjonen foreslås rettet mot (i) aksjeeiere i Selskapet per 1. mars 2022 (som registrert i VPS 3. mars 2022) som (ii) ikke ble tildelt aksjer i Emisjonen og (iii) ikke er bosatt i en jurisdiksjon der et slikt tilbud ville være ulovlig eller, for andre jurisdiksjoner enn Norge, hvor det kreves prospekt, tillatelser, registrering eller lignende. Slike aksjeeiere vil bli gitt ikke-omsettelige retter til å tegne og få tildelt nye aksjer i reparasjonsemisjonen. Opplysningen i børsmeldingen av 28. februar 2022 om at reparasjonsemisjonen vil rettes mot aksjeeiere per 28. februar 2022 (som registrert i VPS 2. mars 2022), er således korrigert.
